

## POWER OF ATTORNEY

For the processing of VAT exemption claims under EU VAT Directive 2006/112/EC

### LEGAL CONTEXT

This power of attorney relates to VAT exemptions granted under Article 151 of EU VAT Directive 2006/112/EC, which provides for tax exemptions on supplies of goods and services to diplomatic missions, consular posts, international organisations, and armed forces of NATO member states.

The administrative procedure for claiming these exemptions is governed by Council Implementing Regulation (EU) No 282/2011, which establishes the Certificate 151 as the standard document for certifying eligibility for VAT exemption across EU Member States.

### GRANT OF AUTHORITY

I, the undersigned, hereby grant power of attorney to NUVONI BV to act on my behalf in all matters relating to the processing of VAT exemption claims under the Certificate 151 procedure, specifically:

#### 1. Submission to Tax Authorities

I authorise NUVONI BV to submit, on my behalf, approved Certificate 151 documents and associated VAT refund claims to the competent tax authorities of EU Member States other than Belgium, including but not limited to:

- Filing refund applications with the relevant tax administration
- Submitting supporting documentation (invoices, proof of payment, Certificate 151 forms)
- Corresponding with tax authorities regarding the status and processing of claims

#### 2. Receipt of Refunds

- I authorise NUVONI BV to receive, on my behalf, any VAT refund amounts granted by non-Belgian tax authorities in relation to purchases covered by approved Certificate 151 documents.

#### 3. Communication with Taxable Persons (Belastingplichtige)

I authorise NUVONI BV to communicate and correspond with suppliers, merchants, and other taxable persons (belastingplichtige) in EU Member States regarding:

- The presentation and validation of Certificate 151 documents
- Requests for VAT refunds on transactions where VAT was charged
- Disputes or clarifications concerning VAT-exempt transactions

#### 4. Administrative Actions

I authorise NUVONI BV to perform all necessary administrative actions in connection with the above, including:

- Signing correspondence and claim forms on my behalf
- Providing additional documentation as requested by tax authorities
- Appointing sub-agents where required by local procedures

### CONDITIONS

- This power of attorney remains in force until revoked in writing by the Principal.
- NUVONI BV shall act in accordance with applicable EU and national legislation governing VAT exemptions for privileged persons and organisations.
- Any VAT refunds received by NUVONI BV on behalf of the Principal shall be transferred to the Principal in accordance with the terms of service agreed between the parties.
- This power of attorney does not extend to matters before Belgian tax authorities, which are governed by separate arrangements.
